PORLOCK CARNIVAL RULES AND CONDITIONS

Entries are free

All monies collected are to be handed to the Carnival Committee for distribution to respective local charities and causes.

Drivers must remain with their vehicles at all times.

All drivers must provide 'Certificate of Insurance' to cover participation in the procession.

The Committee reserve the right to refuse any entry which may cause offences to the public.

All carnival entries will be inspected during registration to ensure compliance of the Porlock Carnival Rules and Conditions.

Floats that have generators must have them in a secure container – re-filling is not permitted during the carnival procession.

No firework, chemicals, air horns or similar audio devices are permitted at the carnival.

No naked flames are permitted unless deemed safe by the Chief Marshall.

No alcohol to be consumed during the carnival procession.

Water or objects must not be thrown during the procession.

Livestock will be permitted at the Committee's discretion.

A safety rail **MUST** be fitted where children are on a float.

A sign saying 'DO NOT CROSS' must be attached between vehicles and trailers.

The Committee's decision in any matter is final.

Floats and participants to gather in The Central Car Park, Porlock **ONE HOUR** before the event.

The Porlock Carnival Committee shall have no liability to participants for any loss or damage of any nature arising from any breach of any express or implied Warranty or Condition or any Negligence, Breach of Statutory or other duty on the part of the Committee or in any way arising out of or in connection with the event, except for death or personal injury resulting directly from the negligence of the Committee.
